

**AGREEMENT BETWEEN THE CITY OF LOS ANGELES  
AND THE CITY OF LONG BEACH**

**ESTABLISHING SPECIFIC CLEAN AIR ACTION PLAN  
COSTS TO BE SHARED**

**AT&T MOBILITY NATIONAL ACCOUNTS LLC  
AIR TIME SERVICES**

WHEREAS, the Cities of Los Angeles and Long Beach, acting by their respective Board of Harbor Commissioners (“Ports”) have entered into Los Angeles Agreement No. 2546/Long Beach Agreement No. HD-7173 (“Master Cost Sharing Agreement”) expressing their desire to share the costs of certain contracts related to the San Pedro Bay Ports Clean Air Action Plan; and

WHEREAS, the Ports are now interested in sharing the cost of a contract for data services for automated vehicle locator devices from AT&T Mobility National Accounts LLC.

NOW, THEREFORE, THE PORTS AGREE AS FOLLOWS:

1. The City of Long Beach has retained AT&T Mobility National Accounts LLC d/b/a AT&T Mobility to provide wireless service to automatic vehicle locator devices on trucks funded through the Ports’ joint Proposition 1B grant programs. The term of the contract is for two years and the total contract amount is \$172,800. The share of the City of Los Angeles shall be 50%; the share of the City of Long Beach shall be 50%.

2. The terms and conditions of the Master Cost Sharing Agreement are incorporated by reference into this agreement and the Ports agree to abide by all the terms and conditions of said agreement.

3. The terms of this cost sharing agreement shall be amended only in writing and signed by both parties.
