Project Description:

Construction and operation of a new near-dock intermodal railyard in the cities of Los Angeles, Carson and Long Beach, generally between Sepulveda Blvd and Pacific Coast Highway, and to the east of the Terminal Island Freeway. The project involves a 3-year construction period requiring demolition of existing improvements and construction of a new railyard consisting of loading tracks, lead tracks, roadway and rail bridge modifications, and other improvements. Operations will occur over a 50-period that will allow the railyard to handle approximately 570,800 Twenty-Foot Equivalent Units (TEU is a measurement for containerized cargo) in its first year of operation.
