An Order of the Board of Harbor Commissioners of the City of Los Angeles (Board) resetting the compensation to be paid by the City of Los Angeles, Department of Recreation and Parks (Permittee), pursuant to Permit No. 147 (Permit).

WHEREAS, the Board and the Permittee entered into the Permit as of June 27, 1969 for a term of fifty (50) years commencing on September 1, 1968: and

WHEREAS, the Permit provides, among other things, that the rental compensation (Rent) to be paid by the Permittee shall be readjusted for each successive five year period; and

WHEREAS, the parties to the Permit have agreed that because of the Permittee's maintenance obligation there shall be no Rent charged for the aforementioned five (5) year period; and

NOW, THEREFORE, IT IS HEREBY ORDERED by the Board of Harbor Commissioner of the City of Los Angeles as follows:

1. There shall be no rent charged for the use of the premises granted under Permit No. 147 for the following five (5) year periods:  
  
September 1, 2013 through August 31, 2018
2. Except as herein provided, each and every one of the covenants, terms and condition of Permit No 147 shall be and remain in full force and effect.
3. The Secretary of the City's Board of Harbor Commissioners shall certify to the adoption of this Order by Said Board of Harbor Commissioners.
