The Engineering Division is currently tracking a total of 117 active Capital projects representing just over \$1.33B in total project value. From a budget perspective, 115 of these projects, or roughly 98% of all projects, are currently tracking on budget.

The 2 projects that are either over budget or at risk of being over budget are:

- 1) The Port Pilot Station Backup Generator and Electrical System Upgrade which may require additional service equipment upgrade at the request of DWP;
- 2) The Cabrillo Beach Eel Grass Mitigation Site. Contractor quote exceeded estimate and is under evaluation;

From a schedule tracking perspective, projects at risk of falling behind schedule include:

1) Six projects in the MOTEMS Program that are currently working through the lease/permit extension process and staff has decided not to advance the projects until the Board of Harbor Commissioners approve the new permits;

Projects that are behind schedule include:

- 1) Three projects for the B. 121-131 (Yang Ming) Terminal Improvements are under re-evaluation of the projects alignment with the Business Development Plan; and also there are new scope elements under consideration for the EIR/EIS;
- 2) The Cabrillo Beach Eel Grass Mitigation Site project is under evaluation and has been deferred to next fiscal year;
- 3) Four projects in the SNAP Program that are delayed due to a re-evaluation of the space needs of the HAB Building;
- 4) The Port Pilot Station Backup Generator and Electrical System Upgrade is on hold pending Port Pilot facility study results which is expected by the end of this calendar year;

JUNE 2015 PDC MEETING RESULTS

Attached for your review is the June 2015 PDC Report. There was no May PDC meeting. This report highlights the actions taken by staff to initiate, review, and resolve items related to Harbor Department project schedules, scopes, and costs.

On June 3, 2015, the PDC met to consider twelve project items. Of those twelve items, four were schedule-related and five were budget-related, and three were new projects. Administrative reports related to work order and the unallocated budget line item were also reviewed. The Unallocated CIP Fund report and meeting minutes are attached for your review.

The following are the results of this meeting (detailed in Transmittal 1):

- Schedule-related Four schedule-related items were submitted and all were approved. Schedule shifts involve changes in cash flow without changing total project cost. The net effect of these changes was a slight reduction in anticipated FY 2014/2015 capital spending. No items require Board action.
- 2) Budget-related Five budget-related items were submitted and four were approved. One item was placed on hold for further discussion.
- 3) New project related Three new projects were submitted and all were approved.

The following summarizes the use of the Unallocated CIP Program Fund Report FY 14/15 (Transmittal 2).

The Board of Harbor Commissioners (Board) approved \$14,662,787 in the Fiscal Year 2014/2015 Capital Improvement Program budget for unallocated capital improvements. This budget is used to either begin new multi-year projects or fully fund projects within the current fiscal year. New projects \$100,000 or above are presented to and approved by the Project Development Committee (PDC). Projects under \$100,000 are reported to the PDC for discussion. Meeting minutes of the PDC are transmitted monthly to the Board for information.

Transmittal 2 lists the new projects that have utilized the Unallocated CIP budget for the current fiscal year to date. The following summarizes these new projects:

- 22 Deferred Maintenance projects for a total of \$4,741,500
- 20 new projects greater than \$100,000 for a total of \$5,676,185
- 1 project requiring a transfer to operating budget for a total of \$2,908,000
- 6 new projects less than \$100,000 for a total of \$386,750

The balance of the Unallocated CIP budget as May 29, 2015 is \$950,352.

Also submitted in Transmittal 2 is the Unallocated CIP Program Fund Report for FY 15/16 (Transmittal 2). The amount for the Fiscal Year 2015/16 Capital Improvement Program budget for unallocated capital improvements is \$15,874,226.

The following summarizes these new projects:

- 21 Deferred Maintenance projects for a total of \$5,109,600
- 4 new projects greater than \$100,000 for a total of \$1,169,000
- 0 project requiring a transfer to operating budget
- 1 new projects less than \$100,000 for a total of \$95,000

The balance of the Unallocated CIP budget as May 29, 2015 is \$9.500,626.

There are various Board approved resources available to move these projects forward. These include in-house staff, on-call consultant contracts, on-call site and marine improvement contracts, annual contracts for supplies and materials to name a few. All these are approved by the Board either as part of the annual budget approval process or multi-year contracts that have received separate Board approval.

AT-GRADE "QUIET ZONE" RAIL CROSSING PROTECTION SYSTEM FOR ANAHEIM STREET RAIL CROSSING OF MCFARLAND
AVENUE LEAD TRACK – COST INCREASE AND TIME EXTENSION REQUEST

SUMMARY

Staff requests approval to increase the project budget by \$140,000 to incorporate the necessary "G" Street rail crossing protection system design upgrades into the scope of work, and provide design support services during construction for the Anaheim Street crossing and "G" Street crossing protection system designs. The City of Los Angeles Department of Transportation (LADOT) will reimburse the City of Los Angeles Harbor Department (Harbor Department) for all design related costs via project federal grant funding.

Revise Construction Finish Date from June 30, 2014 to December 31, 2016

On October 17, 2012, PDC approved the Engineering Work Order (EWO) No. 2521900, which provided funds and time to prepare design drawings, procure materials, and furnish labor to install new Light Emitted Diode (LED) lighting fixtures at HAB's 1st and 2nd floor offices. The approved EWO was budgeted at the amount of \$378,000, with a March 2015 completion date.

During the construction, the Construction and Maintenance (C&M) Division has encountered numerous unforeseen conditions that has increased the project budget from \$378,000 to \$488,000, and has required additional seven months to complete the project.

BERTH 161 MARINE WAYS MODIFICATION

SUMMARY

Debris from maintenance of vessels currently falls onto a mud foundation that is either washed away with the tide or seeps into the soil. It has been requested to design and construct pavement, grade the area, and perform miscellaneous modifications at the Marine Ways to contain work debris, capture and treat contaminated runoff. Improvements will provide compliance with existing water quality regulations. The proposed improvements were originally going to be constructed under the new Marine Improvement's contract. In order to receive a competitive bid, the project will now be bid, awarded and constructed under a separate construction contract. The project will be combined with the Berth 200 Rail Yard Track Connections – Phase 2.

JULY 2015 PDC MEETING RESULTS

Attached for your review is the July 2015 PDC Report. This report highlights the actions taken by staff to initiate, review, and resolve items related to Harbor Department project schedules, scopes, and costs.

On July 1, 2015, the PDC met to consider eight project items. Of those eight items, four were schedule-related and four were budget-related, and none were new projects. Administrative reports related to work order and the unallocated budget line item were also reviewed. The Unallocated CIP Fund report and meeting minutes are attached for your review.

The following are the results of this meeting (detailed in Transmittal 1):

- 1) Schedule-related Four schedule-related items were submitted and all were approved. Schedule shifts involve changes in cash flow without changing total project cost. The net effect of these changes was a slight reduction in anticipated FY 2015/2016 capital spending. No items require Board action.
- 2) Budget-related Four budget-related items were submitted and four were approved.
- 3) New project related No new projects were submitted this month.

The following summarizes the use of the Unallocated CIP Program Fund Report FY 15/16 (Transmittal 2).

The Board of Harbor Commissioners (Board) approved \$15,874,226 in the Fiscal Year 2015/2016 Capital Improvement Program budget for unallocated capital improvements. This budget is used to either begin new multi-year projects or fully fund projects within the current fiscal year. New projects \$100,000 or above are presented to and approved by the Project Development Committee (PDC). Projects under \$100,000 are reported to the PDC for discussion. Meeting minutes of the PDC are transmitted monthly to the Board for information.

Transmittal 2 lists the new projects that have utilized the Unallocated CIP budget for the current fiscal year to date. The following summarizes these new projects:

21 Deferred Maintenance projects for a total of \$5,109,600

- 6 new projects greater than \$100,000 for a total of \$3,025,846
- 2 new projects less than \$100,000 for a total of \$195,000

The balance of the Unallocated CIP budget as June 25, 2015 is \$7,543,780.

There are various Board approved resources available to move these projects forward. These include in-house staff, on-call consultant contracts, on-call site and marine improvement contracts, annual contracts for supplies and materials to name a few. All these are approved by the Board either as part of the annual budget approval process or multi-year contracts that have received separate Board approval.

BERTH 142 CRANE MAINTENANCE BUILDING - SCHEDULE AND BUDGET CHANGE REQUEST

SUMMARY

The Berth 142 Crane Maintenance Building is part of the TraPac Container Terminal Expansion Program. The Board of Harbor Commissioners (Board) approved the Second Amendment to TraPac's Permit No. 881 and Revised Budget on September 19, 2013.

As authorized by the Executive Director on February 26, 2015 the project was advertised and received four bids on May 21, 2015. The announced lowest bidder withdrew his bid, subsequently, the second lowest bidder failed to fully complete the bid proposal as required by the Harbor Department. The Construction Division obtained Board approval to reject all bids and re-bid the contract at the June 18, 2015 Board Meeting.

This re-bid process requires an extension to the original bid and award schedule by five months. In addition, the Engineering Division is recommending an increase of seven months to the original construction schedule to allow for subsurface exploration, procurement of long lead items, and the installation of overhead cranes. The five month time extension due to the re-bid and seven month time increase to the original construction schedule extends the construction completion date by 12 months total.

The Engineering Division also recommends increasing the budget by \$3,800,000 based on the revised cost estimate due to the recent bids, material cost increases, inflation, and additional administrative costs for the schedule extension. Based on the recent construction bids of \$4,953,000, \$6,803,450, \$6,998,070, and \$7,053,950, the Engineering Division revised the construction budget from \$4.2 million to \$7.7 million, a \$3.5 million increase, which includes contingency, and increased the administrative costs by \$300,000 due to the schedule extension for a total budget increase of \$3.8 million.

The funds will come from the TraPac Container Terminal Expansion Program budget. The Berth 142 Crane Maintenance Building is partially funded under the Proposition 1B, State Trade Corridor Improvement Fund, through the State of California Department of Transportation, in the amount of \$2,841,000.

SUMMARY

On July 10, 2012, the Project Development Committee (PDC) approved the project scope, budget, and schedule for this wharf rehabilitation. Staff has since identified contaminated utilities under the deck of the wharf that require removal. Additionally, the existing potable water lines need to be replaced and the wharf needs to be strengthened to support HS-20 traffic loading. This will increase the budget from \$8,794,300 to \$12,311,500 and extend the construction completion date from 11/1/16 to 9/11/17.

SUMMARY

The Berths 212-224 ICTF Expansion consists of one new loading track that will be added to the existing Terminal Island Container Transfer Facility (TICTF) yard. The work was originally included with the Berths 214-220 Redevelopment project, but was removed for grant funding purposes. The work cannot be advertised until grant funds are in place. The work will now be bid and awarded as a separate construction contract. Staff is requesting project schedule approval for the Berths 212-224 ICTF Expansion project.

SUMMARY

On May 20, 2014, the Project Development Committee (PDC) approved the Berths 226-232 Everport Pavement Resurfacing and Striping project. The work consists of resurfacing three inches of asphalt concrete pavement (AC) on the wharf from Berths 226 to 232; 100 feet between the crane rails and 70 feet of backland behind the crane rail.

The project was delayed due to challenges by Everport in finding an opportunity to complete the resurfacing while minimizing impacts to terminal operations. The Port's recent container congestion also added to this challenge. The container congestion has abated and standard operations are now being observed.

Staff requests approval of the revised schedule to proceed with the resurfacing and striping project at the request of the tenant.
