

FIRST AMENDMENT TO AGREEMENT NO. 22-9889  
BETWEEN THE CITY OF LOS ANGELES AND  
RAMBOLL US CONSULTING, INC.

Effective September 1, 2023, this FIRST AMENDMENT to Agreement No. 22-9889 is made and entered into by and between the CITY OF LOS ANGELES, a municipal corporation ("City"), acting by and through its Board of Harbor Commissioners ("Board"), and RAMBOLL US CONSULTING, INC. AND RAMBOLL AMERICAS ENGINEERING SOLUTIONS, INC. ("Consultant") as follows:

1. Section 11.2 is amended to add:

"Notwithstanding the above, Board consents to and approves a one-time assignment from RAMBOLL US CONSULTING, INC. to RAMBOLL AMERICAS ENGINEERING SOLUTIONS, INC., and pursuant to the Assignment and Assumption agreement attached hereto and incorporated by reference as Exhibit J, Ramboll assumes all rights, obligations, and liabilities associated with Agreement No. 22-9889."

2. All references to RAMBOLL US CONSULTING, INC. in Agreement No. 22-9889 are now amended to read RAMBOLL AMERICAS ENGINEERING SOLUTIONS, INC.

Except as amended herein, all remaining terms and conditions of Agreement No. 22-9889 shall remain in full force and effect.
