OCTOBER 2017 PROJECT DEVELOPMENT COMMITTEE REPORT

This report highlights the actions taken by the Project Development Committee (PDC) at its October meeting. On October 4, 2017, the PDC met at its regularly scheduled time to consider nine project items. On September 12, 2017, the PDC met ad hoc to consider one item, for a total of ten items since the previous PDC report. The committee also reviewed administrative reports regarding grants, recently opened work orders, and the status of the unallocated Capital Improvement Program (CIP) fund budget. The meeting minutes (Transmittal 1) and Unallocated CIP Fund Report FY 2017/2018 (Transmittal 2) are attached for your review.

The following is a summary of the meeting minutes by category:

- 1) Schedule change Five items were submitted and approved.
- 2) Budget/Schedule change Two items were submitted and approved.
- 3) New Project Three items were submitted and approved.

The Board approved \$15,000,000 in the fiscal year 2017/2018 CIP budget for unallocated capital improvements. This budget is used to fund new multi-year projects or fully fund projects within the current fiscal year. New projects at or in excess of \$100,000 are presented to the PDC for consideration. Projects under \$100,000 are reported to the PDC for information and discussion. The PDC meeting minutes are then transmitted to the Board for information.

The following is a summary of projects that are expected to utilize the unallocated CIP budget for fiscal year 2017/2018 to date:

11 PDC-approved projects for a total of \$4,884,000

There are various Board-approved resources available to move these projects forward. These include in-house staff, on-call consultant contracts, on-call site and marine improvement contracts, and annual contracts for supplies and materials. All of these are approved by the Board either as part of the annual budget approval process or as multi-year contracts that have received separate Board approval.

PORT POLICE SYSTEMS IMPROVEMENTS – CATALINA ISLAND RADIO REPEATER SITE

SUMMARY

The Information Technology (IT) Division is requesting Project Development Committee (PDC) approval of capital funds for improvements to the Port Police systems. The project is to procure and install a radio repeater site on Catalina Island and a control station for the Point Fermin area. This project is for necessary coverage improvements for the Port Police radio system. The requested amount is \$343,000 in Fiscal Year 2017/18.

Maintenance is covered under warranty for the initial 3 years after installation. Thereafter, maintenance costs are estimated to be approximately \$20,000 per year.

SUBJECT

ORIGINAL PROJECT COST \$7,400,000

BERTHS 177-178 WHARF RESTORATION - NEW PROJECT

SUMMARY

The Engineering Division requests approval of project scope, budget, and schedule to design and construct 375 linear feet of concrete wharf at Berth 178 to replace the existing fire-damaged timber wharf and demolish the 558 lineal feet of fire damaged structure at Berth 177. The project is estimated to cost \$7,400,000 and be completed by October 31, 2019.

BERTHS 218-220 CONCRETE PAVEMENT IMPROVEMENTS - NEW PROJECT

SUMMARY

Staff requests approval to initiate a new project to construct fiber reinforced concrete at the Berths 218-220 crane back reach area. The improvement will accommodate a new type of vessel hatch lid stowed in this area. In the past, vessel hatch lids have typically been flat, which distributes the weight over its surface area. The new hatch lids have footings (see photo 1) which concentrate the weight at those points. Currently the Berths 218-220 back reach area is paved with asphalt concrete, which is not designed to support these concentrated loads (see photo 2). The project is estimated to cost \$837,000 and be completed by December 31, 2018.

BERTHS 148-149 (PHILLIPS 66) MARINE OIL TERMINAL REPAIRS PROJECT - SCHEDULE CHANGE

SUMMARY

The Engineering Division requests the Project Development Committee's (PDC's) approval to extend the project completion date of the Berths 148-149 Marine Oil Terminal (MOT) repairs by nine months. On May 4, 2016, the PDC approved the design and construction of repairs needed at Berths 148-149 to make them compliant to Marine Oil Terminal Engineering and Maintenance Standards (MOTEMS).

The Engineering and Real Estate Divisions have been negotiating a construction schedule with Phillips 66. Agreement to a construction schedule is taking longer than expected due to the high frequency and variability of vessel calls at the terminal. We request a six-month extension to the design completion date to finalize the schedule and avoid advertising the project for construction during the holiday season. In addition, the project will be advertised for construction and will not use the 2016-2018 Marine Improvements Contract as previously approved. An additional three months are requested for the Bid and Award process.

The Engineering Division requests approval for a nine-month time extension to revise the project completion date from November 5, 2018 to August 5, 2019, for additional time needed to negotiate a construction schedule. No budget change is requested.

BERTH 161 - ELEVATOR MODERNIZATION

SUMMARY

Staff requests approval of a revised project schedule and a budget increase for the modernization of the sole elevator serving the old Construction and Maintenance (C&M) Administration Building at Berth 161. A revised schedule would change the project construction start date from August 1, 2017 to December 5, 2017 and construction completion date from November 30, 2017 to July 31, 2018. A budget increase in the amount of \$95,000 is also requested. The Berth 161 Elevator Modernization project is a Deferred Maintenance Capital Improvement Program project approved for Fiscal Year 2016-17.

CHINA SHIPPING SUPPLEMENTAL EIR - SCHEDULE AND BUDGET MODIFICATION

SUMMARY

The City of Los Angeles Harbor Department (Harbor Department) is preparing a Supplemental Environmental Impact Report (SEIR) for the Berths 97-109 [China Shipping] Container Terminal Project (proposed Project), in accordance with the requirements of the California Environmental Quality Act (CEQA). The Notice of Preparation (NOP) for the Draft SEIR was published on September 18, 2015 and the Draft SEIR was released for a 45-day public review period on June 16, 2017. At the public hearing held on July 18, 2017, it was announced that the public review period would be extended by an additional 60 days through September 29, 2017 in response to requests for additional time by stakeholders. On August 16, 2016, PDC approved an estimated budget to complete the SEIR of \$1,100,000. Upon completion of the Draft SEIR public hearing, the SEIR budget has now been fully exhausted. Though the budget to complete the Final SEIR will depend upon the nature and extent of comments received during the Draft SEIR comment period, staff is requesting an estimated budget increase of \$500,000 to complete the environmental document through the Final SEIR, along with an estimated schedule, with the understanding that a more refined estimate of cost and schedule to complete the Final SEIR will be provided to PDC once Draft SEIR comments have been received at the end of the public comment period and an evaluation of true technical and legal support needs can be made at that time. This estimated Final SEIR budget will allow for certain short-term planning activities and limited technical and legal efforts to get underway prior to the end of the Draft SEIR public comment period.
