

**FIRST AMENDMENT TO AGREEMENT
ESTABLISHING SPECIFIC CLEAN AIR ACTION PLAN
COSTS TO BE SHARED**

**BETWEEN THE CITY OF LOS ANGELES
AND THE CITY OF LONG BEACH**

HARDWARE, SOFTWARE AND DATA SERVICES

WHEREAS, the Cities of Los Angeles and Long Beach, acting by their respective Board of Harbor Commissioners ("Ports") have entered into Los Angeles Agreement No. 2546/Long Beach Agreement No. HD-7173 ("Master Cost Sharing Agreement") expressing their desire to share the costs of certain contracts related to the San Pedro Bay Ports Clean Air Action Plan.

WHEREAS, the Ports entered into an agreement to share the cost of a contract for 600 vehicle locators (AVLs) and fleet management services from Webtech Wireless, Inc. (Los Angeles Document No. 08-2724; Long Beach Document No. HD7173J) ("Cost Sharing Agreement").

WHEREAS, the City of Long Beach has entered, or will be entering, into a First Amendment to Agreement HD-7378 with Webtech Wireless, Inc. in the form attached hereto ("First Amendment").

NOW, THEREFORE, THE PORTS AGREE AS FOLLOWS:

1. The City of Long Beach has contracted, or will be contracting, with Webtech Wireless, Inc. to undertake the work set forth in the Cost Sharing Agreement and the First Amendment. The Cities agree to amend the Cost Sharing Agreement by adding the cost of the First Amendment. The total contract amount to be shared by the Cities under the Cost Sharing Agreement is amended to be \$1,069,262. The share of the City of Los Angeles shall be fifty percent (50%); and the share of the City of Long Beach shall be fifty percent (50%).
