### **NOTICE OF COMPLETION OF A DRAFT AMENDMENT NO. 31 TO THE PORT OF LOS ANGELES PORT MASTER PLAN**

Pursuant to the California Coastal Act of 1976, the Los Angeles Harbor Department hereby gives notice to all interested persons, organizations, and agencies that a DRAFT AMENDMENT TO THE PORT OF LOS ANGELES CERTIFIED PORT MASTER PLAN has been prepared as follows:

Draft Port Master Plan Amendment No. 31 – Berths 187-194 map change to Planning Area 2 changing approximately 32 acres of land near Slip 5 and the East basin to reflect existing conditions and a proposed project. The map change was analyzed in the Berths 191-194 [Ecocem] Low-Carbon Cement Processing Facility Project EIR (SCH No. 2022030294).

A public hearing on the draft amendment will be held on June 25, 2026, at 10:00 a.m., during the scheduled meeting of the Los Angeles Board of Harbor Commissioners at the Banning's Landing Community Center, 100 E. Water Street, Wilmington, CA 90744.
