

FIRST AMENDMENT TO AGREEMENT NO. E7083
GRANTED BY THE CITY OF LOS ANGELES
TO R. P. LAURAIN AND ASSOCIATES, INC.

THIS FIRST AMENDMENT to Agreement No. E7083 is made and entered into by and between the CITY OF LOS ANGELES, a municipal corporation ("City"), acting by and through its Board of Harbor Commissioners ("Board"), and R. P. LAURAIN AND ASSOCIATES, INC., a California corporation, 3353 Linden Avenue, Suite 200, Long Beach, CA 90807 ("Consultant") as follows:

1. Paragraph 1, Parties, is revised to correct the legal name of Consultant from "R.P. Laurain & Associates, Inc." to "R. P. Laurain and Associates, Inc."

2. Paragraph 3, Term, is removed in its entirety and replaced with the following paragraph:

"3. Term. This Agreement shall be effective from August 24, 2020 ("Effective Date") and shall continue in effect until all parties have performed to the satisfaction of City or its earlier termination by City upon ten (10) days' written notice to Consultant, but in no event shall the term of this Agreement exceed two (2) years from its Effective Date."

Except as amended herein, all remaining terms and conditions of Agreement No. E7083 shall remain in full force and effect.


