PORT OF LOS ANGELES APPLICATION AND AGREEMENT FOR DIVERS PERMIT (REVOCABLE)

INSTRUCTIONS:

1. Fill out the application for Diver's Permit.
2. Submit two 3/4 inch color photographs of applicant with the application. Please submit a photo with a solid color back ground, no sunglasses, hats, or anything obstructing the face.
3. A permit fee of \$32.61 for the first year is payable in advance or \$13.49 for each yearly renewal thereafter, providing re-evaluation is negative. **Checks are the only approved method of payment**, and **must** be made payable to Port of L.A.
4. A right index fingerprint is required on the permit and on the application.

DIVER PERMIT STANDARDS:

It is the concern of The Los Angeles Port Police Division to provide a safe working environment in the Port of Los Angeles due to ever increasing national security issues.

The application process for an underwater and/or surface diving permit approval period is (3) days, applicants should be advised that a thorough background check will be conducted to assure security standards are met. Applicants are required to submit, in person, a current verifiable home address and phone number, fingerprinting, and two (3/4 X 3/4 in.) recent color photographs.

As a result of this more streamlined application process, it is our intention to increase the level of security within the Port of Los Angeles, those who frequent the Port and the surrounding communities.

REASONS FOR DENIAL:

- An unacceptable arrest history (i.e. any theft, narcotic or felony arrest, etc.)
- Previous conviction/contact by law enforcement for diving without a permit.
- No valid identification.
- No certificate of diving qualifications.
- False/misleading information on the application.
- Any association with domestic or international terrorist organizations.

APPROVED PERMITS:

Diver(s) must call Port Police Dispatch to verify diver(s) identification and report location, time and nature of diving (cleaning, repair, etc.). Diver(s) must call on each day diving is to take place.

Diver(s) must have current issued dive card available, if lost the Port Police must be contacted immediately.

REVOKED PERMITS:

In the event that permit diver(s) fail to comply with the requirements of the permit or the diver(s) violate any Local, State, or Federal laws, the permit can be revoked for (1) year.

Violation of the law while diving in the Los Angeles Harbor can lead to a criminal investigation. Any and all dive equipment, including vessels, will be impounded or booked as evidence at the owner's expense.

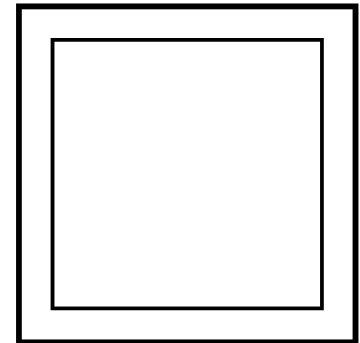

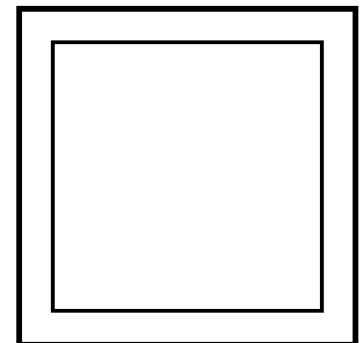

Applicant using a boat agrees to the minimum UCSG standards, plus the following:

1. To have flares, first aid kit, extra float and to display a DIVER FLAG when Diver is down and to cover flag when not diving.
2. To have an assistant 18 years of age or older in the boat during diving operations.
3. Not to dive alone and to be accompanied by a local diver in unfamiliar waters.
4. To conform to existing Federal, State, County and Local laws.
5. To give advance notice of diving within the Los Angeles Harbor to Port Police prior to any dive.

6. To report all injuries and severe mishaps immediately to the Port Police.
7. To immediately notify the Port Police of any lost divers.
