SUBJECT: SALVAGED ITEMS - FISCAL YEAR 2016-17

In June 2016, the Board of Harbor Commissioners (Board) adopted the new Harbor Department Salvage Policy – Resolution 16-7959. The policy grants the Director of Contracts and Purchasing (Purchasing Agent) the authority to determine what personal property is no longer required and how to salvage that property. Any item valued at more than one million dollars will require the Board to approve of that item's disposition.

Section 5 of the new policy directs the Purchasing Agent to prepare a report for the Board listing the items salvaged and the funds received for those salvaged items by the Harbor Department. Transmittal 1 provides that information for the period of July 1, 2016 through June 30, 2017 (Fiscal Year 2016-17).

For FY 2016-17, salvaged items provided a net return of \$75,866.17 to the Harbor Department.
