

FIRST AMENDMENT TO AGREEMENT NO. E-6700
BETWEEN THE CITY OF LOS ANGELES AND
MECKLER BULGER TILSON MARICK & PEARSON LLP

This First Amendment to Agreement No. E-6700 is made and entered into by the City of Los Angeles, a municipal corporation, acting by and through its Board of Harbor Commissioners ("the City"), and Meckler Bulger Tilson Marick & Pearson LLP ("Consultant").

WHEREAS, the City entered into Agreement No.E-6700 with Meckler Bulger Tilson Marick & Pearson LLP, for professional services to review and analyze the legal fees incurred by the City in defense of *United States ex rel Stanley Mosler v. City of Los Angeles et al.* (U.S. District Court Case No. 02-cv-02278) and to provide testimony regarding the reasonableness of these fees in the City's insurance coverage litigation with National Union Fire Insurance Company of Pittsburgh, PA; and

WHEREAS, the term of the one-year Agreement commenced on May 16, 2013 and will be terminating on May 15, 2014; and

WHEREAS, the trial date has been postponed and the City desires to extend the term of the Agreement from one year to three years.

NOW, THEREFORE, the parties agree that:

Section 3. "Term" is replaced by the following:

This Agreement shall be effective from the latest date it is executed on behalf of both parties and shall continue in effect until all parties have performed to the satisfaction of the City or its earlier termination by the City upon ten (10) days' written notice to Consultant but in no event shall the term of this Agreement exceed three years from its effective date.

Except as provided herein, all other terms and conditions of Agreement No. E-6700 shall remain the same.
