RESPONSES TO COMMENTS

2.1 Distribution of the Draft EIS/EIR

The Draft EIS/EIR prepared for the LAHD was distributed to the public and regulatory agencies on June 29, 2007 for a 90-day review period. Approximately 50 copies of the Draft EIS/EIR and 150 summaries were distributed to various government agencies, organizations, individuals, and Port tenants. In addition, postcards in English and Spanish were mailed to all addresses in Wilmington and San Pedro. On July 31, 2007, the review period was extended for a total of 90 days to September 26, 2007. Notice of this change was made at the public meeting on the Draft EIS/EIR, was made by e-mail, published in newspapers and was noticed on the first page of the Port's web site. The 90-day public review period on the Draft EIS/EIR officially closed on September 26, 2007. LAHD, in cooperation with USACE, held a public hearing on the Draft EIS/EIR on July 31, 2007, at Banning's Landing Community Center to provide an overview of the proposed Berths 136-147 Container Terminal Project and accept public comments on the proposed Project.

2.2 Comments on the Draft EIS/EIR

The public comment and response component of the NEPA/CEQA process serves an essential role. It allows the respective lead agencies to assess the impacts of a project based on the analysis of other responsible, concerned, or adjacent agencies and interested parties, and it provides the opportunity to amplify and better explain the analysis that the lead agencies have undertaken to determine the potential environmental impacts of a project. To that extent, responses to comments are intended to provide complete and thorough explanations to commenting agencies and individuals and to improve the overall understanding of the project for the decision-making body.

The USACE and LAHD received 395 comment letters on the Draft EIS/EIR during the public review period. Table 2-1 presents a list of those agencies, organizations, and individuals who provided comment on the Draft EIS/EIR. In addition, written comments regarding global warming mitigation measures were received from the California Attorney General's Office, and are include in Attachment 2.

In addition, responses to global warming mitigation measures issues raised by the California Attorney General's office are provided in Attachment 2. Where responses have resulted in changes to the text of the Draft EIS/EIR, these changes are referenced, and are illustrated in Chapter 3.
