

FIRST AMENDMENT TO AGREEMENT NO. E-6846  
BETWEEN THE CITY OF LOS ANGELES AND  
ZUBER LAWLER AND DEL DUCA

This First Amendment to Agreement No. E-6846 is made and entered into by the City of Los Angeles, a municipal corporation, acting by and through its Board of Harbor Commissioners ("the City"), and Zuber Lawler and Del Duca ("Consultant").

WHEREAS, the City entered into Agreement No.E-6846 with Zuber Lawler and Del Duca, for professional legal services for real property matters; and

WHEREAS, the term of the one-year Agreement commenced on July 16, 2016 and will be terminating on July 15, 2017; and

WHEREAS, the requested work has been ongoing and the City desires to extend the term of the Agreement from one year to three years.

NOW, THEREFORE, the parties agree that:

Section III. "Term of Agreement" is replaced by the following:

This Agreement shall be effective from the latest date it is executed on behalf of both parties and shall continue in effect until all parties have performed to the satisfaction of the City or its earlier termination by the City upon ten (10) days' written notice to Consultant but in no event shall the term of this Agreement exceed three years from its effective date.

Except as provided herein, all other terms and conditions of Agreement No. E-6846 shall remain the same.


