

## Errata for the Berths 136-147 [TraPac] Container Terminal Project Mitigation Monitoring and Reporting Program

On December 6, 2007, the Los Angeles Board of Harbor Commissioners (Board) certified the Final Environmental Impact Report (Final EIR) for the Berths 136-147 [TraPac] Container Terminal Project and adopted a Mitigation Monitoring and Reporting Program (MMRP). The MMRP mistakenly included a mitigation measure for a Source Control Program (Mitigation Measure WQ-3, described below) that applies to marine oil terminal operations that own or operate fuel pipelines or tanks under the Marine Oil Terminal Engineering and Maintenance Standards (MOTEMS) governed by the California State Lands Commission. In the Findings adopted by the Board, it modified Mitigation Measure WQ-3 as a condition of project approval to address Port-wide efforts related to maintaining high water quality conditions rather than as a mitigation measure to reduce a project-specific impact under the California Environmental Quality Act (CEQA). This erratum removes this inapplicable mitigation measure from the MMRP as analyzed in the Second Addendum to the Final EIR prepared on June 30, 2016 because it does not qualify as mitigation under CEQA and does not apply to the Berths 136-147 [TraPac] Container Terminal Project operations as analyzed in the Final EIR.

The SCP shall address immediate leak detection, tank inspection, and tank repair.</del></p> <p><del>As a condition of their lease, the tenant will be required to submit to the Port an annual compliance/performance audit in conformance with the Port's standard compliance plan audit procedures.
