

FIRST AMENDMENT TO AGREEMENT BETWEEN  
THE CITY OF LOS ANGELES AND  
MEYERS NAVE

This First Amendment to Agreement dated for reference purposes as of April 4, 2014, is entered into between the CITY OF LOS ANGELES, a municipal corporation ("City"), acting by and through its Board of Harbor Commissioners ("Board") and the Office of the City Attorney ("City Attorney"), and Meyers Nave, a Professional Law Corporation ("Outside Counsel")

WHEREAS, City and Outside Counsel have entered into an Agreement dated March 1, 2012 for Outside Counsel to provide legal services to assist City Attorney on behalf of the City ("Agreement"); and

WHEREAS, the Agreement was authorized by the City for a term of three years and compensation of \$330,000; and

WHEREAS, the parties desire to increase the compensation by \$657,000 to a total compensation of the Agreement not to exceed \$987,000 as provided for herein.

NOW, THEREFORE, IT IS MUTUALLY AGREED that the Agreement is hereby amended as follows:

1. Subsection A of Article IV, "COMPENSATION," is amended by increasing the maximum payable under this Agreement from Three Hundred Thirty Thousand Dollars (\$330,000) to Nine Hundred Eighty-Seven Thousand Dollars (\$987,000).

Except as amended herein, all remaining terms and conditions of the Agreement shall remain in full force and effect.


