

FIRST AMENDMENT TO AGREEMENT NO. 12-3093
BETWEEN THE CITY OF LOS ANGELES AND
HOOD DESIGN STUDIO, LLC

AGREEMENT NO. 12-3093 ("Agreement No. 12-3093" or "Agreement") by and between the CITY OF LOS ANGELES, a municipal corporation ("City") acting by and through its Board of Harbor Commissioners ("Board") and HOOD DESIGN STUDIO LLC ("Artist") is hereby amended as first time, with respect to the following:

WHEREAS, City, through Board, and Artist entered into Agreement No. 12-3093 on October 10, 2012, for a public art installation at the Wilmington Waterfront Park entitled "Coastline";

WHEREAS, because a number of difficulties related to Artist's procurement of materials and obtaining City permits delayed the start of construction, City and Artist desire to extend the term of the Agreement by six (6) additional months.

WHEREFORE, City and Artist, for good and valuable consideration, enter into this First Amendment to Agreement No. 12-3093 on the following terms and conditions.

1. Section 4.2 is amended by extending the term of the Agreement six (6) additional months such that Section 4.2, as amended, shall read as follows:

"4.2 This Agreement shall be in full force and effect commencing from the date of execution and shall continue until the earlier of the following occurs:

Two (2) years and six (6) months have lapsed from the Effective Date of this Agreement,

or

The Board, in its sole discretion, terminates and cancels all or part of this Agreement for any reason upon giving to Artist ten (10) days' notice in writing of its election to cancel and terminate this Agreement. All progress payments and equitable compensation for time and materials up to the cancellation date shall be paid to the Artist."

2. The effective date of this First Amendment is October 10, 2014.

3. Except as amended herein, all remaining terms and conditions Agreement No. 12-3093 remain the same.
