

FIRST AMENDMENT TO AGREEMENT NO. 15-3327
BETWEEN THE CITY OF LOS ANGELES AND
FULL VISION PRODUCTIONS, LLC

THIS FIRST AMENDMENT to Agreement No. 15-3327, effective July 1, 2015, is made and entered into by and between the CITY OF LOS ANGELES, a municipal corporation ("City"), acting by and through its Board of Harbor Commissioners ("Board"), and FULL VISION PRODUCTIONS, LLC, a Limited Liability California Corporation ("Consultant") as follows:

1. Consultant's name under this Agreement No. 15-3327 is hereby changed from ROBERT MANCIERO dba FULL VISION PRODUCTIONS, LLC to FULL VISION PRODUCTIONS, LLC.

2. Section III.B is amended to read:

"B. This Agreement shall be in full force and effect commencing from the date of execution and shall continue until the earlier of the following occurs:

1. Five (5) years have lapsed from the effective date of this Agreement;

or

2. The Board of Harbor Commissioners, in its sole discretion, terminates and cancels all or part of this Agreement for any reason upon giving to Consultant ten (10) days' notice in writing of its election to cancel and terminate this Agreement."

3. Section V.B is amended to read:

"B. The maximum payable under this Agreement, including reimbursable expenses (See Exhibit B), shall be from a pool of funds established by the City which said pool of funds shall not exceed One Hundred Twenty Thousand Dollars (\$120,000) per year or Six Hundred Thousand Dollars (\$600,000) for the entire five (5) year Term as set forth in Section III.B of this Agreement. Consultant acknowledges that said pool of funds shall also be used to compensate any other contractors or consultants who provide professional writing and editing services to City and such pool of funds shall not be for the exclusive use or payment of Consultant. Consultant further acknowledges that in no event shall Consultant's compensation for the services provided in accordance with this Agreement exceed the aforementioned sum total pool of funds amount set forth herein. Consultant and City agree that Consultant's services set forth in this Agreement are on an as-needed basis and City shall use such services at the sole discretion of the Executive Director or his designee. This Agreement does not guarantee Consultant a fixed amount of work assigned or minimum hours paid."

Except as amended herein, all remaining terms and conditions of Agreement No. 15-3327 shall remain in full force and effect.
