Term	Definition
Aframax	A class of vessels built to maximize shipping rates under the Average Freight Rate Assessment. Aframax tanker vessels carry about 700,000 bbl on average and draft 38-57 feet.
AMP	Alternative Maritime Power, also called shoreside power or cold ironing. The use of shoreside electrical generators, rather than auxiliary ship engines, to provide power for hoteling functions and other functions while the ship is at berth.
Barrel (bbl)	42 gallons.
Crude oil	"Unprocessed" oil that has been extracted from the subsurface. Also known as petroleum, crude oil varies in color from clear to black, and in viscosity from like water to almost solid. Note that the proposed Project would receive crude oil and partially refined crude oil; throughout the SEIS/SEIR these are referred to collectively as "crude oil" (as stated in Section 1.1.2).
HFO	Heavy Fuel Oil, the prevalent fuel used in nearly all marine vessels today. HFO has a worldwide average sulfur content of 2.7 percent by mass, but can range as high as 6 percent sulfur. Effective May 2005, an international convention limits the sulfur content of HFO to 4.5 percent.
Hoteling	The process in which vessels stay docked at the berth while cargo is offloaded and the ship is refueled. Typically involves the continued operation of auxiliary ship engines that are used to generate power to run lights, heating, air conditioning, and hot water for the ship and crew.
Lightering	A process consisting of transferring a portion of cargo from a large vessel ("lightered vessel") to a smaller vessel ("lightering vessel"). Typically lightering occurs when a large vessel can not come into port due to the limited bottom depth at the port. Thus the lightering vessel travels between the lightered vessel and the port to offload cargo.
MDO	Marine Distillate Oil, a marine vessel fuel with a worldwide average sulfur content of approximately 0.5 percent; also known as Marine Diesel Oil
MGO	Marine Gas Oil, a marine vessel fuel averaging 0.05 percent sulfur content.

VLCC	Very Large Crude Carriers, a class of tanker vessels; carries about 2,000,000
	bbl on average and drafts 62-75 feet.
