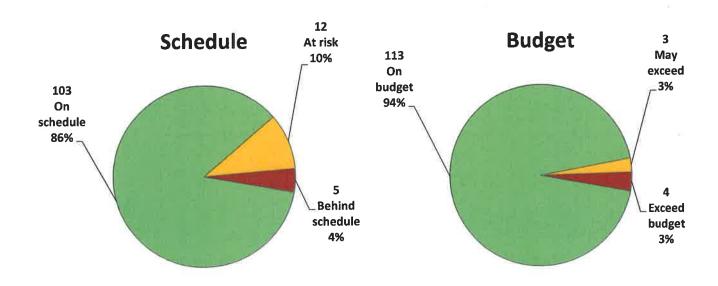

The Engineering Division is currently tracking a total of 133 Capital projects representing just under a \$1 Billion in total project value. 13 projects are currently on hold leaving 120 active projects. From a budget perspective, 113 projects, or roughly 94% of all active projects, are currently tracking on budget.



### The 7 projects that are either over budget or at risk of being over budget include:

- 1) The Berths 97-109 China Shipping Container Terminal Supplemental EIR project is under review and needs PDC action to adjust the budget;
- 2) The Berths 121-131 Terminal Redevelopment EIR project is under review and needs PDC action to adjust the budget;
- 3) The Berths 167-169 Motems (Shell) project is under review and may need PDC action to adjust the budget;
- 4) The Berth 164 Motems (Valero) project is under review and may need PDC action to adjust the budget;
- 5) The San Pedro Waterfront-Ports O' Call Promenade & Town Square project is under review and may need PDC action to adjust the budget;
- 6) The 272 South Fries Ave- Building Improvements project is under review and may need PDC action to adjust the budget;
- 7) The Berth 85-Port Police Float System Replacement project is under review and may need PDC action to adjust the budget.

### The 17 projects that are behind schedule or at risk of falling behind schedule include:

- 1) The Berths 97-109 China Shipping Terminal Supplemental EIR project is delayed and needs PDC action to adjust the schedule;
- 2) The Berths 121-131 Terminal Redevelopment EIR project is delayed and needs PDC action to adjust the schedule;
- 3) The Berths 238-239 Motems (PBF Energy) project is under review and may need PDC action to adjust the schedule;
- 4) The Berths 167-169 Motems (Shell) project is under review and may need PDC action to adjust the schedule;
- 5) The Berth 164 Motems (Valero) project is under review and may need PDC action to adjust the schedule;
- 6) The Berths 148-149 Motems (Phillips 66) Repairs project is under review and may need PDC action to adjust the schedule;
- 7) The Berths 206-209 Building Demolition project is under review and may need PDC action to adjust schedule;
- 8) The Front Street Beautification project is delayed and needs PDC action to adjust the schedule;
- 9) The San Pedro Waterfront- 34.5KV Electrical Utility Service is under review and may need PDC action to adjust the schedule;
- 10) The Wilmington Waterfront Park Street Vacations project is under review and may need PDC action to adjust the schedule;
- 11) The Wilmington Waterfront- Avalon Promenade and Gateway project is delayed and needs PDC action to adjust the schedule;
- 12) The Harbor Administration Building HVAC Replacement project is under review and may need PDC action to adjust the schedule;
- 13) The 272 Fries Ave. Building Improvements project is under review and may need PDC action to adjust the schedule;
- 14) The Berth 85 Port Police Float System Replacement is under review and needs PDC action to adjust the schedule;

- 15) The Cabrillo Marina Way Electrical Service Meter Separation project is under review and may need PDC action to adjust the schedule;
- 16) The 249 Cannery Building Demolition Project is under review and may need PDC action to adjust the schedule;
- 17) The Berth 51 Access Improvement Project is under review and may need PDC action to adjust the schedule.
