

FIRST AMENDMENT TO AGREEMENT NO. 13-3139
BETWEEN THE CITY OF LOS ANGELES AND
TRANSPORTATION POWER, INC.

THIS FIRST AMENDMENT to Agreement No. 13-3139 is made and entered into by and between the CITY OF LOS ANGELES, a municipal corporation ("City"), acting by and through its Board of Harbor Commissioners ("Board"), and TRANSPORTATION POWER, INC. ("Consultant") as follows:

1. Section IV is amended to read:

"IV. EFFECTIVE DATE AND TERM OF THE AGREEMENT

This Agreement shall be in full force and effect commencing from the date of execution by the Executive Director and shall continue until the earlier of the following occurs:

1. Three (3) years have lapsed from the effective date of this Agreement; or
 2. The Board of Harbor Commissioners, in its sole discretion, terminates and cancels all or part of this Agreement for any reason upon giving to GRANTEE ten (10) days' written notice of its election to cancel and terminate this Agreement; or
 3. GRANTEE has completed the PROJECT and the City has made final payment pursuant to the requirements of the Agreement."
2. Exhibit A - Project Scope and Payment Schedule is amended as follows:
 - Task #1.4: Approximate Timing is changed from 03/31/2014 to 09/30/2015
 - Task #2.2: Approximate Timing is changed from 06/30/2014 to 06/30/2015
 - Task #2.3: Approximate Timing is changed from 12/31/2014 to 12/31/2015

Except as amended herein, all remaining terms and conditions of Agreement No. 13-3139 shall remain in full force and effect.
