

SECOND AMENDMENT TO  
FOREIGN-TRADE ZONE AGREEMENT NO. 2369  
BETWEEN THE CITY OF LOS ANGELES  
AND  
INDUSTRIAL DEVELOPMENTS INTERNATIONAL, INC.

THIS SECOND AMENDMENT to Agreement No. 2369 is made between the CITY OF LOS ANGELES, a municipal corporation (hereinafter called "City"), acting by and through its Board of Harbor Commissioners (hereafter called "Board"), and INDUSTRIAL DEVELOPMENTS INTERNATIONAL, INC. (hereafter called "Developer").

WHEREAS, Developer wishes to change its name; and

WHEREAS, Developer's FTZ site located in the City of Mira Loma became part of a newly incorporated City; and

WHEREAS, City and Developer wish to extend the Term of Agreement No. 2369 an additional five (5) years; and

NOW, THEREFORE, BE IT RESOLVED, that Agreement No. 2369 between the City of Los Angeles and Industrial Developments International, Inc., be hereby amended as follows:

1. Developer's name is changed from Industrial Developments International, Inc. to Industrial Developments International, LLC.
2. On July 1, 2011, parts of Mira Loma became part of the newly incorporated City of Jurupa Valley. Developer's FTZ site location changed from the City of Mira Loma to the City of Jurupa Valley.
3. Section III. TERM AND RENEWAL, the term of this Agreement shall be extended an additional five (5) years beginning on March 1, 2015 and ending on February 28, 2020.

Except as amended herein, all remaining terms and conditions of Agreement No. 2369 shall remain in full force and effect.
