

SECOND AMENDMENT TO AGREEMENT NO. E-6774
BETWEEN THE CITY OF LOS ANGELES AND
G4S INVESTIGATIONS

This Second Amendment to Agreement No. E-6774 is made and entered into by the City of Los Angeles, a municipal corporation, acting by and through its Board of Harbor Commissioners ("the City"), and G4S Investigations ("Consultant").

WHEREAS, the City entered into Agreement No.E-6774 with G4S Investigations, for professional investigation services for Workers' Compensation claims; and

WHEREAS, the term of the two-year Agreement commenced on February 27, 2015 and will be terminating on February 26, 2017; and

WHEREAS, the requested work has been ongoing and the City desires to extend the term of the Agreement from two years to three years.

NOW, THEREFORE, the parties agree that:

Section III. "Term of Agreement" is replaced by the following:

This Agreement shall be effective from the latest date it is executed on behalf of both parties and shall continue in effect until all parties have performed to the satisfaction of the City or its earlier termination by the City upon ten (10) days' written notice to Consultant but in no event shall the term of this Agreement exceed three years from its effective date.

Except as provided herein, all other terms and conditions of Agreement No. E-6774 shall remain the same.
