

ORDER NO. 11-7097

An Order of the Board of Harbor Commissioners of the City of Los Angeles fixing the compensation to be paid by the City of Los Angeles Department of Recreation and Parks under Permit No. 147 for the following five-year periods:

September 1, 1998 through August 31, 2003

September 1, 2003 through August 31, 2008

September 1, 2008 through August 31, 2013

WHEREAS, the Board of Harbor Commissioners of the City of Los Angeles and the Department of Recreation and Parks of the City of Los Angeles ("Permittee") acting by and through the Board of Recreation and Park Commissioners entered into Permit No. 147 ("Permit") on June 27, 1969 for a term of fifty years commencing September 1, 1968;

WHEREAS, Permit No. 147 provides, among other things, that the rental compensation ("Rent") to be paid by Permittee shall be readjusted for each successive five-year period;

WHEREAS, the parties to the Permit have agreed that because of Permittee's maintenance obligation there shall be no Rent charged for the aforementioned five-year periods.

NOW, THEREFORE, the Board of Harbor Commissioners hereby orders as follows:

Section 1. There shall be no Rent charged for the use of the premises granted under Permit No. 147 for the following three five-year periods:

September 1, 1998 through August 31, 2003

September 1, 2003 through August 31, 2008

September 1, 2008 through August 31, 2013

Section 2. Except as herein provided, each and every one of the covenants, terms and conditions of Permit No. 147 shall be and remain in full force and effect.

Section 3. The Secretary of City's Board of Harbor Commissioners shall certify to the adoption of this Order by said Board of Harbor Commissioners.
