ADOPTION OF THE 2024 BOARD OF HARBOR COMMISSIONERS MEETING
CALENDAR

BE IT RESOLVED BY THE BOARD OF HARBOR COMMISSIONERS OF THE
CITY OF LOS ANGELES, AS FOLLOWS:

Section 1. Regular meetings of the Board of Harbor Commissioners of the City of Los Angeles in calendar year 2024 shall be held on the date, time, and location indicated on the attached exhibit.

If at any time any regular meeting of the Board of Harbor Commissioners falls on a holiday, such regular meeting shall be held on the next business day or as rescheduled in a special meeting in compliance with the Brown Act; and provided further, that if by reason of fire, flood, earthquake, or other emergency it shall be unsafe to meet at the place above designated, the meeting may be held for the duration of the emergency at such place as is designated by the President or, in his/her absence, by the Vice President of the Board of Harbor Commissioners, with notice to be given pursuant to the Brown Act.

Section 2. The Board of Harbor Commissioners may adjourn, continue or re-continue any regular, adjourned regular, special, or adjourned special meeting to a time and place specified in the order or resolution of adjournment. If the subsequent meeting is conducted within five (5) days of the original meeting, matters placed on the agenda for the original meeting may be considered at the subsequent meeting. If the subsequent meeting is more than five (5) days from the original meeting, a new agenda must be prepared and properly posted consistent with the Brown Act. Continued hearings shall be subject to the same procedures. Less than a quorum may so adjourn from time to time. If all the members of the Board are absent from any regular or adjourned regular meetings, the Secretary of the Board of Harbor Commissioners may declare the meeting adjourned to a stated time and place, and said Secretary shall cause a written notice of adjournment to be given in the same manner as provided for special meetings unless said notice is waived as provided for special meetings. A copy of the order, resolution, or notice of adjournment shall be conspicuously posted by the Secretary on or near the door of the place where the regular, adjourned regular, special, or adjourned meeting was held within twenty-four (24) hours after the time of adjournment. When a regular or adjourned regular meeting is adjourned as provided in this section, the resulting adjourned regular meeting is a meeting for all purposes. When an order or resolution of adjournment of any meeting fails to state the hour to which the adjourned meeting is to be held, it shall be held at the hour specified for regular meetings.

Section 3. Special meetings of the Board of Harbor Commissioners of the City of Los Angeles may be called at any time by the presiding officer of the Board or by members thereof to be held at such time and place as may be designated in such call by delivering personally or by e-mail written notice of such call to each member of the Board and to each local newspaper of general circulation, radio, or television station requesting such notice in writing, and posting a notice on the Harbor Department's Website at www.portoflosangeles.org.

Such notice shall be delivered personally or by e-mail and shall be received and posted in a publicly accessible location at least twenty-four (24) hours before the time of such meeting as specified in the notice. The call and/or e-mailed notice shall specify the time and place of the special meeting by the Board and the business to be transacted. No other business shall be considered at such special meetings by the Board. Such written notice may be dispensed with as to any member of the Board who, at or prior to the time the meeting convenes, files with the Secretary of the Board a written waiver of notice, which such waiver may be given by e-mail, and as to any member who is actually present at the meeting at the time it convenes. Special meetings may also be called in accordance with the provisions of Government Code Section 54956 and 54956.5.
