## FIRST AMENDMENT TO AGREEMENT NO. E-7080 BETWEEN THE CITY OF LOS ANGELES AND PHILIP J. REICHERT

THIS FIRST AMENDMENT to Agreement No. E-7080 is made and entered into by and between the CITY OF LOS ANGELES, a municipal corporation ("City"), acting by and through its Board of Harbor Commissioners ("Board"), and PHILIP J. REICHERT ("Consultant") as follows:

## Section 3 is amended to read:

## "3. TERM OF AGREEMENT

This Agreement shall be in full force and effect commencing from the date of execution and shall continue until the earlier of the following occurs:

- 1. Two (2) years have lapsed from the effective date of this Agreement; or
- The Board of Harbor Commissioners, in its sole discretion, terminates and cancels all or part of this Agreement for any reason upon giving to Consultant ten (10) days' notice in writing of its election to cancel and terminate this Agreement. "
- 2. Section 5(B) is amended to read:
  - "B. The maximum payable under this Agreement, including reimbursable expenses (see Exhibit B), shall be Three Hundred Thousand Dollars (\$300,000)."
- Section 11 is amended to read:

## "11. TERMINATION PROVISION

The Board of Harbor Commissioners, in its sole discretion, shall have the right to terminate and cancel all or any part of this Agreement for any reason upon giving the Consultant ten (10) days' advance, written notice of the Board's election to cancel and terminate this Agreement. It is agreed that any Agreement entered into shall not limit the right of the City to hire additional consultants or perform the services described in this Agreement either during or after the term of this Agreement."

Except as amended herein, all remaining terms and conditions of Agreement No. E-7080 shall remain in full force and effect.

Subject to the provisions of Charter Section 245, the effective date of this Amendment shall June 11, 2021 upon its execution by Executive Director after

authorization of the Board. Consultant is aware that the City Council, pursuant to Charter Section 245 of the City of Los Angeles, has the right to review this Amendment. Accordingly, in no event shall this Amendment be signed by the Executive Director until after the expiration of the fifth Council meeting day after Board action, or the date of City Council's approval of the Amendment.
