

**FIRST AMENDMENT TO AGREEMENT NO. 22-9860
BETWEEN THE CITY OF LOS ANGELES AND
ANCHOR QEA, LLC
Name Changed to
ANCHOR QEA, Inc.**

THIS FIRST AMENDMENT to Agreement No. 22-9860 is made and entered into by and between the CITY OF LOS ANGELES, a municipal corporation ("City"), acting by and through its Board of Harbor Commissioners ("Board"), and ANCHOR QEA, Inc., a Washington corporation, formerly known as ANCHOR QEA, LLC as follows:

WHEREAS, in May 2022, City entered into Agreement No. 22-9860 ("Agreement"), with Anchor QEA, LLC ("Anchor QEA") for as-needed environmental services on a wide range of water quality, sediment quality and biological resources; and

WHEREAS, Anchor QEA, LLC changed their entity information with the California Secretary of State from ANCHOR QEA, LLC, a Limited Liability Company, to ANCHOR QEA, Inc., an Out of State Stock Corporation, with an initial filing date of June 4, 2024; and

WHEREAS, the purpose of this First Amendment is to acknowledge the entity information change and confirm the Parties intent to continue the Agreement in full force and effect.

NOW, THEREFORE, IT IS MUTUALLY AGREED AS FOLLOWS:

1. The Parties agree that Anchor QEA shall now be referred to under Agreement No. 22-9860 and any subsequent amendment, invoices, and otherwise, as Anchor QEA, Inc., a Washington corporation, whose address is 1201 3rd Avenue, Suite 2600, Seattle, WA 98101. Therefore, each reference in Agreement No. 22-9860 to Anchor QEA, LLC shall mean Anchor QEA, Inc. unless the context requires otherwise.
2. Except as amended herein, all remaining terms and conditions of Agreement No. 22-9860 shall remain in full force and effect.

Subject to the provisions of Charter Section 245, the effective date of this Amendment shall be the date of its execution by Executive Director upon authorization of the Board. Consultant is aware that the City Council, pursuant to Charter Section 245 of the City of Los Angeles, has the right to review this Amendment. Accordingly, in no event shall this Amendment become effective until after the expiration of the fifth Council meeting day after Board action, or the date of City Council's approval of the Amendment.
