

FIRST AMENDMENT TO  
FOREIGN TRADE ZONE OPERATING AGREEMENT NO. 2648  
BETWEEN THE CITY OF LOS ANGELES AND  
FUJITRANS USA, INC.

THIS FIRST AMENDMENT to Foreign Trade Zone (FTZ) Operating Agreement No. 2648 (hereinafter referred to as "Agreement") is made and entered into by the CITY OF LOS ANGELES, a municipal corporation, acting by and through its Board of Harbor Commissioners (hereinafter referred to as "City"), and FUJITRANS USA, INC. (hereinafter referred to as "Operator").

WHEREAS, Operator's contact person has changed; and

WHEREAS, the parties agree to add the Wilmington Truck Route language to Agreement No. 2648; and

WHEREAS, the parties to Agreement No. 2648 also agree to extend the Term an additional five (5) years.

NOW, THEREFORE, BE IT RESOLVED, that Agreement No. 2648 between the City of Los Angeles and Fujitrans USA, Inc. is hereby amended as follow:

1. Operator's contact person is changed from Hiroyuki Sugino to Hirotoshi Kitano.
2. ARTICLE II. AUTHORITY GRANTED/ACCEPTED, TERM AND AGREEMENT, Section 2.03 Term of Agreement, subsection A. Term and Renewal, the initial term of this Agreement shall be extended an additional five (5) years beginning on August 31, 2013 and ending on August 30, 2018.
3. ARTICLE VI. ADMINISTRATION AND OPERATION OF ZONE shall include the following sections and language:

6.04 Wilmington Truck Route

It is recognized by both parties that the Operator does not directly control the trucks serving the Port. However, the Operator shall notify truck drivers, truck brokers and trucking companies that trucks serving FTZ warehouses and originating in the Port of Los Angeles must confine their route to the designated Wilmington Truck Route of Alameda Street and "B" Street; Figueroa Street from "B" Street to "C" Street; and Anaheim Street east of Alameda Street. A copy of the Wilmington Truck Route is attached as Exhibit C, which may be modified from time to time at the sole discretion of the Executive Director with written notice to Operator.

Except as provided herein, all other terms and conditions of Agreement No. 2648 shall remain the same.
