

SECOND AMENDMENT TO AGREEMENT NO. 17-3471
BETWEEN THE CITY OF LOS ANGELES
AND
JACOBS ENGINEERING GROUP, INC.

THIS SECOND AMENDMENT to Agreement No. 17-3471 is made and entered into by and between the CITY OF LOS ANGELES, a municipal corporation ("City"), acting by and through its Board of Harbor Commissioners ("Board"), and JACOBS ENGINEERING GROUP, INC., a Delaware corporation ("Consultant") as follows:

1. Subsection 4.2 of Section 4, "Effective Date and Term", is amended by increasing the term of the Agreement so that it shall not exceed six (6) years.
2. Subsection 4.2c of Section 4, "Effective Date and Term", is amended by increasing the term from three (3) years to six (6) years elapsing from the effective date of the Agreement.
3. Consultant is aware that pursuant to Charter Section 373 and Administrative Code Section 10.5, this Amendment requires approval by City Council prior to becoming effective.
4. Except as amended herein, all remaining terms and conditions of Agreement No. 17-3471 shall remain in full force and effect.
