

ORDER NO. _____

An Order of the Board of Harbor Commissioners of the CITY OF LOS ANGELES approving and consenting to the transfer of ownership and control of CAL MARINE FISH COMPANY, LLC, a California limited liability company, pursuant to Permit No. 892.

WHEREAS, Permit No. 892 was granted by the CITY OF LOS ANGELES to TRI MARINE FISH COMPANY, LLC, effective June 7, 2011; and

WHEREAS, the corporate name of TRI MARINE FISH COMPANY, LLC was changed to CAL MARINE FISH COMPANY, LLC effective September 14, 2021; and

WHEREAS, CAL MARINE FISH COMPANY, LLC submitted a Transfer Notice to the City of Los Angeles pursuant to Section 10(c) of Permit No. 892 seeking the consent of the CITY OF LOS ANGELES to a Transfer within the meaning of Section 10 of Permit No. 892; and

WHEREAS, the Transfer Notice CAL MARINE FISH COMPANY, LLC submitted describes the Transfer as ASP CAL MARINE INC. acquiring one hundred percent (100%) of the equity interests of CAL MARINE FISH COMPANY, LLC (the "Transaction"); and

WHEREAS, after the consummation of the Transaction, CAL MARINE FISH COMPANY, LLC will remain the tenant under Permit 892; and

WHEREAS, contingent upon the closing of the Transaction, CAL MARINE FISH COMPANY, LLC will pay a one-time assignment fee of \$982,622.00 pursuant to Section 10(g) of Permit 892; and

WHEREAS, contingent upon the closing of the Transaction, the existing guaranty furnished by Inter Oceanic Holding, LLC will be terminated effective as of the date of this order; and

WHEREAS, following the closing of the Transaction, the obligations of CAL MARINE FISH COMPANY, LLC under Permit No. 892 are guaranteed by American Seafood Partners, Inc.;

THE BOARD OF HARBOR COMMISSIONERS OF THE CITY OF LOS ANGELES DOES HEREBY ORDER AS FOLLOWS:

Section 1. The Board of Harbor Commissioners of the CITY OF LOS ANGELES hereby approves and consents to the transfer of ownership and control of CAL MARINE FISH COMPANY, LLC pursuant to Permit No. 892 as described in the Transfer Notice provided that:

(a) The consent and approval hereby expressed shall not waive any of the rights of the CITY OF LOS ANGELES under Permit No. 892 as to the Transferor or the Transferee, nor shall the same be deemed or construed in any way to amend, extend, abridge, or interpret any of the provisions of Permit No. 892; and

(b) Transferor shall remain bound by all terms and conditions of Permit No. 892.

Section 2. A true copy of the Transfer Notice shall be filed in the office of the Secretary of the Board of Harbor Commissioners.

Section 3. The Board Secretary shall certify to the adoption of this Order by the Board of Harbor Commissioners of the CITY OF LOS ANGELES.


