SUBJECT: REQUEST FOR PROPOSALS FOR OCCUPATIONAL HEALTH AND SAFETY SERVICES AND TRAINING

Pursuant to the Occupational Health and Safety Services and Training Request for Proposals (RFP), all proposers were to submit any questions regarding this RFP by no later than December 7, 2023. Questions were to be submitted in writing, and all questions and responses were to be posted on the Department's website and www.rampla.org.

Below is a list of questions received from proposers, and the Department's response:

- 1. Q: Attachment A: Is the pricing for NO. 3a-3e for Initial or Refresher Training? The course titles listed on these line items range from 4-40hrs depending on topic, and Initial or Refresher Training.
 - A: Submit pricing for both initial and refresher and specify class time duration. Add additional line items/information if the existing attachment does not specify.
- 2. Q: Attachment A: NO. 3f Indicated "Refresher", can you please verify what type of asbestos refresher training? Refresher training duration varies by topic, and they can be anywhere from 2-8hrs, so pricing may vary depending on the type of refresher.
 - A: Submit refresher cost for applicable categories and specify class time duration. Add additional line items/information if the existing attachment does not specify.
- 3. Q: Are vendors required to provide pricing for all programs/topics listed in Attachment A?
 - A: Yes, vendors are required to submit pricing if they wish to provide training services in that category. No pricing indicates the vendor is unable to provide training services for that topic and will be excluded from that category.
- 4. Q: Attachment A: Are students expected to receive an NCCCO certification upon completion of line item 13d? Is this price to include the Written and Practical Exam, as well as NCCCO fees?
 - A: Yes students are expected to receive NCCCO Certification upon completion. Pricing shall include all fees associated with the written, practical and application fees. Add additional line items/information if the existing attachment does not specify.

- 5. Q: Attachment A: NO. 27-30 Indicate OSHA Training, are those classes to be per Cal/OSHA or Federal OSHA Standards?
 - A: The Harbor Department's preference is Cal OSHA where applicable.
- 6. Q: Attachment A: NO. 41a indicates "Awareness/Refresher", they are not one in the same, they are 2 separate classes. Can you please clarify if this class is a Lead Awareness or Lead Refresher Course accredited by the CDPH?
 - A: Submit pricing for both Awareness and Refresher and specify class time duration. Add additional line items/information if the existing attachment does not specify. These classes do not require CDPH accreditation.
- 7. Q: Attachment A: Is the pricing for NO. 41b-d for Initial or Refresher Training?
 - A: Submit pricing for both Initial and Refresher and specify class time duration. Add additional line items/information if the existing attachment does not specify.
- 8. Q: Attachment A: Are there any specific certification requirements for NO. 48 Railroad Worker Safety? What kind of Railroad Worker certificate do they need?
 - A: The Railroad Worker Safety training shall be in accordance with CFR, FRA and DOT while working within close proximity to our local railway system operator (Pacific Harbor Line) in the Port of Los Angeles. The close proximity work may be connected to operations and maintenance related work on behalf of the Port of Los Angeles and not affiliated with railway operations and maintenance.
- 9. Q: Attachment A: NO. 48 Railroad Worker Safety Are there instructor credential requirements/is this an accredited course overseen by a specific entity?
 - A: The Railroad Worker Safety training shall be in accordance with CFR, FRA and DOT while working within close proximity to our local railway system operator (Pacific Harbor Line) in the Port of Los Angeles. The close proximity work may be connected to operations and maintenance related work on behalf of the Port of Los Angeles and not affiliated with railway operations and maintenance. This presentation will need to incorporate Pacific Harbor Line operational requirements.
- 10. Q: Attachment A: NO. 48 References T49 CFR 219: "49 CFR Part 219 mandates that employers of roadway workers provide specific training to supervisors of roadway workers to prevent injuries to roadway workers and to prevent damage to railroad equipment and property caused by roadway workers impaired by alcohol and controlled substances." –is this correct? Previously POLA has requested training referencing T49 CFR 214.
 - A: We will amend to read "49 CFR 214".
- 11. Q: Attachment A: Item NO. 49 -Is the Fit Testing Qualitative or Quantitative?
 - A: Respiratory Fit Testing shall be qualitative (not quantitative) testing.
- 12. Q: Attachment A: Who is the audience, that is what is their line of work as it pertains to the training, for the following NO.'s:
