WHEREAS, in February 2022, City entered into three service authorizations under the umbrella of Agreement No. 21-9847 ("Agreement") between City and AT&T Corp. for AT&T Corp. to provide and maintain the Harbor Department's telecommunications and data network services:

WHEREAS, AT&T Enterprises, LLC is the successor in interest to AT&T Corp. by merger and conversion as a result of the following activity: on May 1, 2024, AT&T Corp., a New York corporation, merged into AT&T Enterprises, Inc., a Delaware corporation, and on May 2, 2024, AT&T Enterprises, Inc. converted to AT&T Enterprises, LLC, a Delaware limited liability company; and

WHEREAS, the purpose of this First Amendment is to provide notice of the succession of the contracting party.

NOW, THEREFORE, IT IS MUTUALLY AGREED AS FOLLOWS:

- The Parties agree that AT&T Corp. shall now be referred to under Agreement No. 21-9847 and any subsequent amendment, invoices, and otherwise, as its successor in interest, AT&T Enterprises, LLC. Therefore, each reference in Agreement No. 21-9847 to "AT&T" shall, unless the context otherwise requires, mean AT&T Enterprises, LLC.
- 2. Except as amended herein, all remaining terms and conditions of Agreement No. 21-9847 shall remain in full force and effect.

Subject to the provisions of Charter Section 245, the effective date of this Amendment shall be the date of its execution by Executive Director upon authorization of the Board. Consultant is aware that the City Council, pursuant to Charter Section 245 of the City of Los Angeles, has the right to review this Amendment. Accordingly, in no event shall this Amendment become effective until after the expiration of the fifth Council meeting day after Board action, or the date of City Council's approval of the Amendment.
