Proposal Review Results

Proposals were individually reviewed and each rater scored using a range of 0 to 5 for each criteria, with 5 being exceptionally well qualified and 0 being not included/non-responsive. A weighting factor and weighted score were used for the proposal review process, as shown on the attached RFP Selection Evaluation Form. The results are summarized in Table 1.

Interview Results

The top seventeen (17) firms were invited to interview based on a qualifying score of 350 or higher. During the interview process, each firm responded to a set of questions formulated by the selection committee.
