FIRST AMENDMENT TO AGREEMENT NO. 11-2979 BETWEEN THE CITY OF LOS ANGELES AND ROBERT P. HENRY, JR.

THIS FIRST AMENDMENT to Agreement No. 11-2979 is made and entered into by and between the CITY OF LOS ANGELES, a municipal corporation ("City"), acting by and through its Board of Harbor Commissioners ("Board"), and ROBERT P. HENRY, JR. ("Consultant") as follows:

- Section III.B is amended to read:
 - B. This Agreement shall be in full force and effect commencing from the date of execution and shall continue until the earlier of the following occurs:
 - 1. Two (2) years and six (6) months have elapsed from the effective date of this Agreement;

or

- 2. The Board of Harbor Commissioners, in its sole discretion, terminates and cancels all or part of this Agreement for any reason upon giving to Consultant ten (10) days' notice in writing of its election to cancel and terminate this Agreement.
- 2. Section V.B. is amended to read:
 - B. The maximum payable under this Agreement, including reimbursable expenses (see Exhibit B), shall be Three Hundred Sixty Eight Thousand Six Hundred Dollars (\$368,600). And, the \$2,500 limit on reimbursement set forth is Exhibit B shall be an annual limit.

Except as amended herein, all remaining terms and conditions of Agreement No. 11-2979 shall remain in full force and effect.
