

FIRST AMENDMENT TO AGREEMENT NO. E-6779
BETWEEN THE CITY OF LOS ANGELES AND
JACKSON DEMARCO TIDUS PECKENPAUGH

THIS FIRST AMENDMENT to Agreement No. E-6779 is made and entered into by and between the CITY OF LOS ANGELES, a municipal corporation ("City"), acting by and through its Board of Harbor Commissioners ("Board") and the Office of the City Attorney ("City Attorney"), and JACKSON DEMARCO TIDUS PECKENPAUGH now called "JACKSON TIDUS" ("Outside Counsel") as follows:

1. Section II.A. Period of Performance is amended to read as follows:

"This Agreement shall begin on April 1, 2015 and shall continue until March 31, 2018, unless terminated earlier under the provisions of this Agreement."

2. The first sentence of Section V.A. Appropriation of Funds is amended to read as follows:

"The Board has appropriated Three Hundred Fifty Thousand Dollars (\$350,000) for this Agreement to cover legal services paid for at hourly rates set forth on Exhibit B."

Except as amended herein, all remaining terms and conditions of Agreement No. E-6779 shall remain in full force and effect.
