If the Vendor maintains higher limits than the minimums shown below, the City requires and shall be entitled to coverage for the higher limits maintained by the Vendor. Vendor shall certify that it is aware of the provisions of Section 3700 of the California Labor code which requires every employer to be insured against liability for Workers' Compensation or to undertake selfinsurance in accordance with the provisions of that Code, and that Vendor shall comply with such provisions before commencing the performance of the tasks under this Purchase Order. Coverage for claims under U.S. Longshore and Harbor Workers' Compensation Act, if required under applicable law, shall be included. Vendor shall submit Workers' Compensation policies whether underwritten by the state insurance fund or private carrier, which provide that the public or private carrier waives its right of subrogation against the City in any circumstance in which it is alleged that actions or omissions of the City contributed to the accident. Railroad Protective Liability Insurance

Railroad Protective Liability Insurance in which Pacific Harbor Line (PHL) acting for itself as the named insured with the Vendor, shall also be submitted. The minimum limits of Railroad Protective Liability Insurance shall be the limits normally carried by the Vendor but not less than \$2,000,000 combined single limit for property damage and bodily injury including death.
