An Order of the Board of Harbor Commissioners of the CITY OF LOS ANGELES approving and consenting to the transfer of ownership or control of WESTOIL TUG SERVICES, INC., a Washington corporation, pursuant to Permit No. 882.

WHEREAS, Permit No. 882 was granted by the CITY OF LOS ANGELES to MILLENNIUM MARITIME, INC. effective February 26, 2010; and

WHEREAS, the corporate name of MILLENNIUM MARITIME, INC. was changed to WESTOIL TUG SERVICES, INC. effective February 2, 2021; and

WHEREAS, the obligations of WESTOIL TUG SERVICES, INC. under Permit No. 882 are guaranteed by HARLEY MARINE SERVICES, INC., a Washington corporation; and

WHEREAS, the corporate name of HARLEY MARINE SERVICES, INC. was changed to CENTERLINE LOGISTICS CORPORATION and the entity was converted to a Delaware corporation effective January 22, 2020; and

WHEREAS, WESTOIL TUG SERVICES, INC. submitted a Transfer Notice to the CITY OF LOS ANGELES pursuant to Section 14.2 of Permit No. 882 seeking the consent of the CITY OF LOS ANGELES to a Transfer within the meaning of Section 14 of Permit No. 882, and

WHEREAS, the Transfer Notice WESTOIL TUG SERVICES, INC. submitted describes the Transfer as ALIMPIK TUG & BARGE HOLDCO 1, LLC (the Parent Holding Company) acquiring one hundred percent (100%) of the shares of CENTERLINE LOGISTICS CORPORATION (the Parent Company of WESTOIL TUG SERVICES, INC.) through a successful credit bid at an auction held by the King County Sheriff's Office in Washington State on June 27, 2019;

THE BOARD OF HARBOR COMMISSIONERS OF THE CITY OF LOS ANGELES DOES HEREBY ORDER AS FOLLOWS:

Section 1. The Board of Harbor Commissioners of the CITY OF LOS ANGELES hereby approves and consents to the transfer of ownership or control of WESTOIL TUG SERVICES, INC. pursuant to Permit No. 882 as described in the Transfer Notice provided that:

- (a) The consent and approval hereby expressed shall not waive any of the rights of the CITY OF LOS ANGELES under Permit No. 882 as to the Transferor or the Transferee, nor shall the same be deemed or construed in any way to amend, extend, abridge, or interpret any of the provisions of Permit No. 882; and
- (b) Transferee shall agree to be bound by all terms and conditions of Permit No. 882.

Section 2. A true copy of the Transfer Notice shall be filed in the office of the Secretary of the Board of Harbor Commissioners.

Section 3. The Board Secretary shall certify to the adoption of this Order by the Board of Harbor Commissioners of the CITY OF LOS ANGELES.
