**SUBJECT: PUBLIC REVIEW PERIOD CLARIFICATION ON THE RECIRCULATED DRAFT ENVIRONMENTAL IMPACT REPORT FOR THE SOUTHERN CALIFORNIA INTERNATIONAL GATEWAY PROJECT**

The City of Los Angeles Harbor Department (LAHD) released a Recirculated Draft Environmental Impact Report (EIR) for the Southern California International Gateway Project on September 27, 2012 showing a 45-day public review period closing on November 9, 2012. The correct end date for the 45-day review period is Saturday, November 10, 2012. Since the corrected 45-day public review period ends on Saturday, November 10, 2012, the comment period automatically extends to the next business day which is now November 13, 2012.
