Clean Truck Fund Rate Collection, Spending Update & Project Approval

Board Items for Consideration



Staff requests Board approval of two items:

- 1. First Amendment to Agreement with PortCheck to collect the Clean Truck Fund Rate
- Memorandum of Understanding with the South Coast Air Quality Management District (SCAQMD) to contribute funding to the Mobile Source Air Pollution Reductions Review Committee's (MSRC) ZE infrastructure projects

Staff Recommendation #1



Approve First Amendment to the Clean Truck Fund (CTF) Rate Collection Agreement among POLA, Port of Long Beach (POLB), PortCheck, and the Marine Terminals Operators.

- Extends the Agreement by five (5) years for a total of eight (8) years
- Expands the data collected by PortCheck in order to meet State truck regulation requirements
- Increases the funding amount by ~\$21 million for a not to exceed amount of ~\$31 million
 - PortCheck costs will be split between POLA and POLB

THE PORT OF LOS ANGELES

CTF Rate Collection Background

- PortCheck was selected through a competitive request for proposals
- CTF Rate Collection Agreement was approved by the Board on 05/20/2021
- CTF Rate for \$10/TEU (\$20 containers >20 ft) on loaded containers started on 04/01/2022
 - Low NOx and zero-emission (ZE) trucks are exempt
- PortCheck collects the CTF Rate and provides truck move data to the Ports
- Administrative costs are deducted from the monies collected from the CTF Rate

PortCheck Cost Increase



Administrative costs were based on projected throughput of the Ports for the next five (5) years

- Bank and credit card fees for processing the CTF Rate were previously ~2% of revenue and is expected to increase to ~3% over the course of the agreement
- Increased labor costs due to inflation and additional data processing to meet State regulatory reporting requirements
- Additional ~\$250,000 to upgrade IT equipment and enhanced cyber security measures
- Additional 5% contingency was added to the amendment for any unforeseen costs

CTF Rate Collection – Year 2



Exempt Truck Trip Data

Year 1 = 04/01/2022 - 03/31/2023	107,342	~ 5%
Year 2 = 04/01/2023 - 03/31/2024	131,352	~ 6%

294 ZE trucks as of 05/01/2024

- Approximately \$ 89 million collected from 04/01/2022 to 06/01/2024
- Approximately \$ 2.93 million in administrative costs as of 06/01/2024
- Total CTF Rate revenue as of 06/01/2024 = Approximately \$ 86 million

Staff Recommendation #2



Approve the Memorandum of Understanding (MOU) with SCAQMD, on behalf of Mobile Source Air Pollution Reductions Review Committee (MSRC), to fund public charging of heavy-duty trucks

- Funded by Clean Truck Fund Rate (CTF Rate)
- \$12,520,661 for 207 chargers (POLB will provide same amount)
- Eight (8) public truck charging projects within the South Coast Air Basin
- SCAQMD will administer funds on behalf of MSRC
- Upon infrastructure completion, recipients will submit biannual usage reports for up to five (5) years to POLA via SCAQMD

CTF Rate Allocation as of 06/01/2024

 POLA Zero-Emission (ZE) Truck Voucher Incentive Program (POLA Voucher Program) through CARB's Hybrid and ZE Bus & Truck Voucher Incentive Project (HVIP)

Program opened on 09/12/2022
Total allocation = \$40 Million
Voucher plus up of \$75,000 per truck or \$100,000 per truck for small fleets
As of 06/01/2024 = 266 ZE trucks reserved = ~\$25.9 million
Remaining Voucher Funding = ~\$14 million



CTF Rate Allocation – Previous Approval

CTF Rate Allocation as of 06/01/2024

- Two (2) ZE 25 Projects = \$3 Million each (\$6 Million total)
 Total 22 ZE trucks
 - One project is complete
 - Second project pending charging infrastructure completion
- Joint Electric Truck Scaling Initiative (JETSI) = \$1.5 Million
 - Deployment of 100 ZE trucks
- Wilmington Public Charging Station (pending future board approval)
 - Request for Proposal (RFP) process complete
 - \$6 million for infrastructure

 - Funding of new emerging technologies or business models for ZE Trucks via Ports' Technology Advancement Program (TAP)
- 4. Grants
 - Continue to apply for grant funding opportunities and collaborate with agencies
