

FIRST AMENDMENT TO AGREEMENT NO. 19-3655
BETWEEN THE CITY OF LOS ANGELES AND
CISION US INC.

THIS FIRST AMENDMENT to Agreement No. 19-3655 is made and entered into by and between the CITY OF LOS ANGELES, a municipal corporation ("City"), acting by and through its Board of Harbor Commissioners ("Board"), and CISION US INC. ("Consultant") as follows:

1. Section III(B) is amended to read:

"III. EFFECTIVE DATE AND TERM OF AGREEMENT

B. This Agreement shall be in full force and effect commencing from the effective date and shall continue until the earlier of the following occurs:

1. May 20, 2024, five (5) years from the effective date of the Agreement;

or
2. Prior to the end of any billing quarter, either party may provide thirty (30) days written notice of its election to terminate this Agreement. Termination of the Agreement shall be at the end of the then-current billing quarter, and the City shall pay for services provided through the termination effective date.

2. Section V(B) is amended to read:

"B. The maximum payable under this Agreement shall be Ninety-Two Thousand Three Hundred Ninety-Eight Dollars (\$92,398).

3. Exhibit A "Scope of Work and Compensation" is removed in its entirety and replaced with Exhibit A-1 "Scope of Work and Compensation" which is attached hereto and made a part hereof.

Except as amended herein, all remaining terms and conditions of Agreement No. 19-3655 shall remain in full force and effect.


