## SUBJECT: REQUEST FOR PROPOSALS FOR TRANSPORTER REFURBISHMENT SERVICES

Pursuant to the TransPORTer Refurbishment Services Request for Proposals (RFP), all proposers were to submit any questions regarding this RFP by no later than February 21, 2024. Questions were to be submitted in writing, and all questions and responses were to be posted on the Department's website and www.rampla.org.

Below is a list of questions received from proposers, and the Department's response:

- 1. Q: We are currently verified as a SBE on Ramp LA and meet the listed requirements for VSBEs. How do we go about being certified as a VSBE with the Port?
  - A: A step by step guide is provide <u>here</u>.
- 2. Q: What is the allotted budget range for this project?
  - A: The exact amount is TBD. The estimated budget ranges between \$200,000 and \$500,000.
- 3. Q: Is there an opportunity to apply for this opportunity solely as a subcontractors?
  - A: The Harbor Department will accept proposals from firms that can provide all of the requirements of the Scope of Work. Proposers are encouraged to utilize RampLA for outreach to potential subcontractors. A list of firms who have downloaded the opportunity is attached.
- 4. Q: Is the scope of work for photography solely providing photographs of the assembly and disassembly of the new TransPORTer? That was all that I could find in the documentation. If so, wouldn't that be the responsibility of the contractors who build the machine (as it is part of the warrantied products they're providing)? "The manual will consist of an annotated compilation of drawings (as built) and any pertinent photographs taken during the construction and installation of an exhibit. The photos will

illustrate the proper method for dismantling and re-assembling the exhibit and its component parts..." and "Examples of exhibits which fall under the warranty: • Photographs that fade, bubble, peel, shrink or craze " Is there any photography needed for the interactive exhibits?

A: The request for photography and drawings are for any new equipment that will be built by the contractor to be used in the TransPORTer. Any photography to be used in the TransPORTer as part of the interactive exhibits will be provided by the Harbor Department. The Scope of Work is not a request for photography services.
