

SECOND AMENDMENT TO AGREEMENT NO. 16-3436
BETWEEN THE CITY OF LOS ANGELES
AND
ENVIRONMENTAL COMPLIANCE SOLUTIONS, INC.

THIS SECOND AMENDMENT to Agreement No. 16-3436 is made and entered into by and between the CITY OF LOS ANGELES, a municipal corporation ("City"), acting by and through its Board of Harbor Commissioners ("Board"), and ENVIRONMENTAL COMPLIANCE SOLUTIONS, INC. ("Consultant") as follows:

1. Section V, subsection B, is amended to increase the maximum payable amount as follows:

"V. COMPENSATION AND PAYMENT

B. The maximum payable under this Agreement, including reimbursable expenses (see Exhibit B), shall be Three Million Nine Hundred Thousand Dollars (\$3,900,000). The total sum paid under this Agreement shall be determined by Project Directives and Consultant acknowledges that final compensation may not reach the maximum payable amount allowed for herein."

Except as amended herein, all remaining terms and conditions of Agreement No. 16-3436 shall remain in full force and effect.
