

FIRST AMENDMENT TO AGREEMENT NO. 21-9826
BETWEEN THE CITY OF LOS ANGELES AND
SIERRA CYBERNETICS, INCORPORATED

THIS FIRST AMENDMENT to Agreement No. 21-9826 is made and entered into by and between the CITY OF LOS ANGELES, a municipal corporation ("City"), acting by and through its Board of Harbor Commissioners ("Board"), and SIERRA CYBERNETICS, INCORPORATED, a California corporation, 5140 E. LaPalma Avenue, Suite 201, Anaheim Hills, California 92807-2069 ("Consultant") as follows:

1. Section 5. "COMPENSATION AND PAYMENT", Subsection B, shall be amended to increase compensation by an additional amount of Nine Hundred Seventy Thousand Dollars (\$970,000) and will read as follows:

"B. The maximum payable under this Agreement, including reimbursable expenses (see Exhibit A), shall be Two Million Four Hundred Seventy Thousand Dollars (\$2,470,000)."

Subject to the provisions of Charter Section 245, the effective date of this Amendment shall be the date of its execution by Executive Director upon authorization of the Board. Consultant is aware that the City Council, pursuant to Charter Section 245 of the City of Los Angeles, has the right to review this Amendment. Accordingly, in no event shall this Amendment become effective until after the expiration of the fifth Council meeting day after Board action, or the date of City Council's approval of the Amendment.

Except as amended herein, all remaining terms and conditions of Agreement No. 21-9826 shall remain in full force and effect.
