

FIRST AMENDMENT TO AGREEMENT NO. E-7261
BETWEEN THE CITY OF LOS ANGELES AND
NUMARC US, INC.

THIS FIRST AMENDMENT to Agreement No. E-7261 is made and entered into by and between the CITY OF LOS ANGELES, a municipal corporation ("City"), acting by and through its Board of Harbor Commissioners ("Board"), and NUMARC US, INC. ("Consultant") as follows:

1. Section 3 is amended to read:

"3. TERM OF AGREEMENT

The term of this Agreement shall be a period of three years from the date of execution of this Agreement by the Executive Director."

2. Section 5(B) is amended to read:

"B. The maximum amount payable under this Agreement, including reimbursable expenses (see Exhibit B), shall be One Hundred Eighty Thousand Dollars (\$180,000)."

Except as amended herein, all remaining terms and conditions of Agreement No. E-7261 shall remain in full force and effect.

Subject to the provisions of Charter Section 245, the effective date of this Amendment shall be the date of its execution by Executive Director upon authorization of the Board. Consultant is aware that the City Council, pursuant to Charter Section 245 of the City of Los Angeles, has the right to review this Amendment. Accordingly, in no event shall this Amendment become effective until after the expiration of the fifth Council meeting day after Board action, or the date of City Council's approval of the Amendment.


