

FIRST AMENDMENT TO AGREEMENT NO. 22-9899
BETWEEN THE CITY OF LOS ANGELES AND
AECOM TECHNICAL SERVICES, INC.

THIS FIRST AMENDMENT to Agreement No. 22-9899 is made and entered into by and between the CITY OF LOS ANGELES, a municipal corporation ("City"), acting by and through its Board of Harbor Commissioners ("Board"), and AECOM TECHNICAL SERVICES, INC. ("Consultant") as follows:

1. Section 5 Compensation, Subsection 5.1 is amended to read:

" 5.1 For the full and satisfactory performance of the Scope of Work, City shall pay Consultant and Consultant shall accept a sum not to exceed Seven Million Dollars (\$7,000,000) to be paid as specified in Exhibit "E". If Exhibit "E" allocates a specific amount to the performance of a Task or Subtask and if, following the completion of such Task or Subtask, unexpended sums remain in relation to such specific amount, Executive Director may, upon written notice to Consultant, allocate such unexpended sums to the performance of a subsequent Task or Subtask."

Except as amended herein, all remaining terms and conditions of Agreement No. 22-9989 shall remain in full force and effect.

Subject to the provisions of Charter Section 245, the effective date of this Amendment shall be the date of its execution by Executive Director upon authorization of the Board. Consultant is aware that the City Council, pursuant to Charter Section 245 of the City of Los Angeles, has the right to review this Amendment. Accordingly, in no event shall this Amendment become effective until after the expiration of the fifth Council meeting day after Board action, or the date of City Council's approval of the Amendment.
