

FIRST AMENDMENT TO AGREEMENT NO. 22-9896
BETWEEN THE CITY OF LOS ANGELES AND
OCEAN BLUE ENVIRONMENTAL SERVICES, INC.

THIS FIRST AMENDMENT to Agreement No. 22-9896 is made and entered into by and between the CITY OF LOS ANGELES, a municipal corporation ("City"), acting by and through its Board of Harbor Commissioners ("Board"), and OCEAN BLUE ENVIRONMENTAL SERVICES, INC. ("Consultant") as follows:

1. Section 5.1 is amended to read:

"5.1 For the full and satisfactory performance of the Scope of Work, City shall pay Consultant and Consultant shall accept a sum not to exceed Two Million Nine Hundred Seventy-Seven Thousand Dollars (\$2,977,000). The total sum payable under this Agreement shall be determined by Project Directives and Consultant acknowledges that final compensation may not reach the maximum sum allowed for herein."

Except as amended herein, all remaining terms and conditions of Agreement No. 22-9896 shall remain in full force and effect.

Subject to the provisions of Charter Section 245, the effective date of this Amendment shall be the date of its execution by Executive Director upon authorization of the Board. Consultant is aware that the City Council, pursuant to Charter Section 245 of the City of Los Angeles, has the right to review this Amendment. Accordingly, in no event shall this Amendment become effective until after the expiration of the fifth Council meeting day after Board action, or the date of City Council's approval of the Amendment.
