

FIRST AMENDMENT TO AGREEMENT NO. E6832
BETWEEN THE CITY OF LOS ANGELES AND
CALIFORNIA YACHT MARINA, L.P.

THIS FIRST AMENDMENT to Agreement No. E6832 is made and entered into by and between the CITY OF LOS ANGELES, acting by and through the Executive Director of the Harbor Department ("City"), acting by and through its Board of Harbor Commissioners ("Board"), and CALIFORNIA YACHT MARINA, L.P., a limited partnership, Berth 200, #36, Wilmington, California 90744 ("Grantee") as follows:

1. Section 3 is amended to read:

"3. Term. This Agreement shall be effective from the latest date it is executed on behalf of both parties and shall continue in effect until Grantee has performed to the satisfaction of City or its earlier termination by City upon ten (10) days' written notice to Grantee, but in no event shall the term of this Agreement extend beyond April 6, 2019."

Except as amended herein, all remaining terms and conditions of Agreement No. E6832 shall remain in full force and effect.


