FIRST AMENDMENT TO MEMORANDUM OF AGREEMENT NUMBER C-134257 OF CITY OF LOS ANGELES CONTRACT BETWEEN THE CITY OF LOS ANGELES AND THE CITY OF LOS ANGELES HARBOR DEPARTMENT

THIS FIRST AMENDMENT to the Memorandum of Agreement Number <u>C-134257</u> ("First Amendment") is made and entered into by and between the City of Los Angeles, a municipal corporation (the "City") and the City of Los Angeles Harbor Department ("Port of Los Angeles"), a proprietary department of the City of Los Angeles ("Subrecipient").

WITNESSETH

WHEREAS, the City and the Subrecipient entered into that certain City of Los Angeles Subaward Agreement Number C-134257 (the "Agreement"), related to the Fiscal Year 2018 Urban Areas Security Initiative Grant ("UASI 18" or the "Grant"), whereby the City agreed to disburse UASI 18 grant funds to Subrecipient in accordance with the UASI 18 approved budget and Subrecipient agreed to use the grant funds to support the development and sustainment of core capabilities as outlined in the National Preparedness Goal by addressing the unique equipment, training, planning, organization, and exercise needs of the Los Angeles/Long Beach Urban Area ("LA/LBUA"), and assisting it in building an enhanced and sustainable capacity to prevent, protect against, mitigate, respond to, and recover from acts of terrorism; such Agreement having a term of September 1, 2018 to May 31, 2021, with an original allocation of UASI 18 grant funds to Subrecipient in the amount of Three Million Four Hundred Ninety-Three Thousand Seven Hundred Twenty-Nine Dollars (\$3,493,729.00), and the execution of said Agreement having been authorized by the Los Angeles City Council (C.F. #18-0397, 4/18/19); and

WHEREAS, the City and the Subrecipient desire to decrease Subrecipient's UASI 18 grant fund allocation amount as a result of cost-savings by Sixty-Nine Thousand Thirty-Seven Dollars (\$69,037.00) ("Decrease"), resulting in a total allocation of Three Million Four Hundred Twenty-Four Thousand Six Hundred Ninety-Two Dollars (\$3,424,692.00), and such Decrease having been authorized under Section 14.8 of the Los Angeles City Administrative Code ("Section 14.8"); and

WHEREAS, Section 3.12 of the Agreement provides for amendments to the Agreement; and

WHEREAS, the City, through its Mayor's Office of Public Safety ("Mayor's Office"), which has been designated by the City to administer the Agreement and the

project contemplated therein, and Subrecipient desire to enter into this First Amendment to: (a) decrease Subrecipient's allocation by Sixty-Nine Thousand Thirty-Seven Dollars (\$69,037.00); and (b) to make such other changes as are required in connection with the foregoing, all as detailed elsewhere in this First Amendment and as authorized by the Los Angeles City Council (C.F. #18-0397, 4/18/19) and Section 14.8; and

WHEREAS, this First Amendment is necessary and proper to continue and/or complete certain activities authorized under the Agreement.

NOW, THEREFORE, the City and Subrecipient hereby covenant and agree that Memorandum of Agreement No. C-134257 be amended, effective upon signature of all the parties, as follows:

1. Section 1.2 of this Agreement entitled "Subaward Information and Period of Performance" is hereby amended in its entirety to read::

"Subrecipient hereby accepts the following subaward ("Subaward") of the Federal award upon the terms and conditions set forth in this Agreement:

Subaward amount:

\$3,424,692.00

Subaward Period of Performance ("Term"):

September 1, 2018

to May 31, 2021

Match Requirement:

None

The term of this Agreement shall be the "Term" as set forth in this Section 1.2."

- 2. Subrecipient's UASI 18 grant funds allocation set forth in the Agreement is amended to reflect the modification by the parties. The Workbook (as such term is defined in the Agreement) shall be amended accordingly to reflect such modification and Subrecipient's use of grant funds.
- 3. The services and activities procured under this Agreement shall be subject to all applicable Los Angeles County Department of Public Health Officer Orders and all City of Los Angeles COVID-19 Orders and Ordinances applicable to this Agreement.

Except as herein amended or modified, all terms and conditions of the Agreement shall remain unchanged and in full force and effect by way of this First Amendment.

This First Amendment may be executed in one or more counterparts, and by the parties in separate counterparts, each of which when executed shall be deemed to be an

original but all of which taken together shall constitute one and the same agreement. The parties further agree that facsimile signatures or signatures scanned into .pdf (or signatures in another electronic format designated by City) and sent by e-mail shall be deemed original signatures.

This First Amendment includes four (4) pages which constitute the entire understanding and agreement of the parties with respect to the matters set forth herein.
