

FIRST AMENDMENT TO AGREEMENT NO. E-6723  
BETWEEN THE CITY OF LOS ANGELES AND  
THE STANZLER LAW GROUP

This First Amendment to Agreement No. E-6723 is made and entered into by the City of Los Angeles, a municipal corporation, acting by and through its Board of Harbor Commissioners ("the City"), and The Stanzler Law Group ("Consultant").

WHEREAS, the City entered into Agreement No.E-6723 with The Stanzler Law Group, for professional services to generate an expert opinion report and to provide expert witness trial testimony in *City of Los Angeles v. National Union Fire Insurance Company of Pittsburgh, PA*, (U.S. District Court Case No. 12-cv-07662), regarding insurance claims handling and National Union's handling of the City's claims related to *United States ex rel Stanley Mosler v. City of Los Angeles et al.* (U.S. District Court Case No. 02-cv-02278).

WHEREAS, the term of the one-year Agreement commenced on September 20, 2013 and will be terminating on September 19, 2014; and

WHEREAS, the trial date has been postponed and the City desires to extend the term of the Agreement from one year to three years.

NOW, THEREFORE, the parties agree that:

Section 3. "Term" is replaced by the following:

This Agreement shall be effective from the latest date it is executed on behalf of both parties and shall continue in effect until all parties have performed to the satisfaction of the City or its earlier termination by the City upon ten (10) days' written notice to Consultant but in no event shall the term of this Agreement exceed three years from its effective date.

Except as provided herein, all other terms and conditions of Agreement No. E-6723 shall remain the same.
