SUBJECT: NOTICE OF AVAILABILITY OF A DRAFT SUPPLEMENTAL ENVIRONMENTAL IMPACT REPORT FOR THE BERTHS 97-109 [CHINA SHIPPING] CONTAINER TERMINAL PROJECT (SCH #2003061153)

The City of Los Angeles Harbor Department (LAHD) has prepared a Draft Supplemental Environmental Impact Report (SEIR) to supplement and update the Berths 97-109 [China Shipping] Container Terminal Project Environmental Impact Statement/Environmental Impact Report (EIS/EIR) certified by the City of Los Angeles Board of Harbor Commissioners on December 18, 2008. The 2008 EIS/EIR evaluated the environmental impacts of the construction and operation of the China Shipping Container Terminal at Berths 97-109. This Draft SEIR evaluates the continued operation of the terminal under new and/or modified mitigation measures, along with an incrementally higher cargo throughput level compared to that assumed in the 2008 EIS/EIR. The analysis contained in the Draft SEIR examines whether potentially new significant environmental impacts or substantially more severe impacts would occur in the areas of Air Quality, Greenhouse Gases, and Ground Transportation. The Draft SEIR was prepared in accordance with current City of Los Angeles Guidelines for the Implementation of the California Environmental Quality Act (CEQA) of 1970, Article I; the State CEQA Guidelines, Article 7, Sections 15086-15087; and the California Public Resources Code Section 21153.

Availability:

The Draft SEIR is being circulated for a period of 45 days for public review and comment starting on June 16, 2017, and ending on July 31, 2017.
